**Auction Notice for disposal of old cut down trees lying at DM office,  
Coochbehar**

An Open Auction bid will be held on **30/06/2016 at 11.00 am** at the Conference hall – 1 of the DM office, Coochbehar for auction of the old trees previously cut down and stacked at the premises of DM office, Coochbehar. The trees will be disposed off on "**As is where basis is**". Details of the same can be seen at the nezarath section of DM office during office hours on any working day.

Interested parties are requested to visit the spot and inspect the materials on any working days between 11.00Hrs to 16.00Hrs up to 29/06/2016 in the premises of DM office, Coochbehar.

**TERMS & CONDITIONS**

1. The intending bidders/ agencies have to bring and submit the PAN Card, Society registration (for co-operative societies), Trade License, and the earnest money before taking part in the bid process.
2. Earnest Money: An earnest money of Rs.3,000/- (Rupees three thousand) only is to be deposited by way of Bank draft/ bankers cheque payable on Coochbehar in favour of the District Magistrate, Coochbehar or in cash before starting of bids.
3. The list of trees attached with this notice is tentative only. The actual quantity may vary with the list. The intending bidders are therefore requested to inspect the materials at the site before submitting their bid. The authority will bear no responsibility for any shortage/excess of materials in comparison to the material list.
4. The successful bidder has to deposit the full amount of his bid price after deducting the earnest money amount within 2 (two) working days from the date of acceptance letter failing which his earnest money may be forfeited and the rate offered by second highest bidder may be accepted.
5. The time is the essence of contract. The successful bidder must lift the materials within 7 (seven) working days from the date of acceptance of his bid at his own cost. The successful agency has to make its own security arrangement for protection of the materials from the date of acceptance of his bid up to lifting of the materials by him. If any agency fails to complete the work within the stipulated time, the order issued in his favour may be cancelled without assigning any reason thereof. The undersigned may also proceed to award the order to other agencies.
6. Acceptance of highest bid is not obligatory and the undersigned reserves the right to accept or reject any or all the bids without assigning any reasons what so ever.
7. The registered co-operative societies should also submit their audited balance sheet for last financial year and NOC from ARCS along with the technical bid.
8. Necessary deduction of taxes will be deducted at source as per Government rules.
