Sealed tenders in printed form as specified are invited by the Secretary, Debutter Trust Board for the following work from the eligible tenderers as per particulars given below and will be received by the Secretary, Debutter Trust Board, Cooch Behar on behalf of the Debutter Trust Board, Cooch Behar.

- a) Name of the work : **COLOUR WASHING, PRIMING AND PAINTING OF MADAN MOHAN TEMPLE AND BOUNDARY WALL, DOLL SHADE, OFFICE ROOM AND FRONT GATES OF M.M. TEMPLE AT MADAN MOHAN THAKURBARI UNDER D.T.B, COOCH BEHAR.**
- b) Name & address of the Engineer-in-charge : Technical person of Debutter Trust Board, Cooch Behar.
- c) Contractor eligible to submit tender : Validly enlisted to PWD / Z.P (W.B) / P.S (W.B), reliable, bonafied, resourceful contractor having executed in similar nature of constructional work of more than 2.35 lac only in a single work under any Govt. agency in last three years and valid certificate of GST and P.T. (in Form No.XIX) and [all in original & 1 set in Xerox copies must be self attested], I.T return of last financial year alongwith PAN card xerox.
- d) Estimated value of work put to tender : Rs.3,98,761.00 (Rupees Three Lakh Ninety Eight Thousand Seven Hundred Sixty One) only.
- e) Earnest Money : Rs.8,000.00 (Rupees Eight Thousand) only in form of NSC/KVP/DCR/Bankers Cheque/DD of any Nationalised Bank in favour of Secretary, Debutter Trust Board, Cooch Behar payable at Cooch Behar. NSC must be pledged in favour of Secretary, D.T.B.
- f) Printed form in which tender is to be submitted : In printed Debutter Trust Board Tender Form.
- g) Price per copy of the set of tender documents : Rs.1000.00 (Rupees One Thousand) only per Set.
- h) Last date of receiving application for tender documents : 27-09-2018 upto Office Hours.
- i) Last date & time limit for issuing tender documents : 01-10-2018 upto Office Hours.
- j) Last date time limit & place for dropping of tender documents (Through Post) : 05-10-2018 upto 4: P.M at Debutter Trust Board, Cooch Behar.
- k) Date, time & place of opening the tender : 05-10-2018 at 5:00 P.M at Debutter Trust Board, Cooch Behar.

- l) Time of completion of work : 20 (Twenty) days from the date of issue of work order unless any specific order of the authority failure of which will lead to recovery of damarage cost caused by non-completion of work within specified time.
- m) Mode of issue of tender paper : Tender paper will be issued by the Secretary, Debutter Trust Board, Cooch Behar.
- n) Location of Godown from which Deptt. Materials (if any) may be issued : Madan Mohan Temple under Debutter Trust Board, Cooch Behar (will be issued exclusively on recommendation of the Engineer-in-charge).

The tender documents and other relevant particulars (if any) may be seen by the intending tenderer during Office hours in the Office of the Debutter Trust Board, Cooch Behar. Application (in duplicate) along with the proof of their current Credential of satisfactory completion of similar nature of work for Rs.2,35,000/- and valid certificate of GST, P.T (in form XIX) & PAN Card (each documents should be in original & 1 Set of XEROX) will have to be submitted to the Office of the Secretary, Debutter Trust Board, Cooch Behar failing of which no permission for purchasing tender paper will be accorded. Submission of original certificates is must. Intending tenderer may apply and obtain tender papers will in advance to guard against any difficulties due to possible absence from the headquarters of the Secretary and concerned schedule of rates and site condition well in advance. No authorized persons will be allowed to apply and purchase the tender forms. Percentage rate (At par/Less/Above) than the estimate put to tender should be quoted both in figure as well as in words. All corrections in the tender should have initials with date. Any tender paper which does not fulfill any of the above condition or becomes incomplete in any respect shall liable to be rejected.

No Tender Paper shall be accepted by hand or by any other means except through Registered Post / Speed Post of the Department of Post, Govt. of India. Tenderers are requested to take adequate care while mailing their papers by Registered Post / Speed Post so that it reaches the undersigned on or before 05-10-2018 upto 4 P.M.

The Contractor must obtain the License under the Contract of Labour (Regulation & Abolition Act, 1970) and produce as and when necessary. This may strictly be followed otherwise it will mean violation of contract.

In addition to all usual deductions a further deduction of labour CESS @1% of gross bill value will be made against the work.

The Secretary, Debutter Trust Board, Cooch Behar reserves the right to accept or to cancel any or all tenders without assigned any reasons thereof to the tenderers.
