RE- TENDER NOTICE FOR CARRYING OF FOOD STUFF AND OTHERS

Sealed Tenders are invited by the undersigned from the bonafide and reputed Renderers' / Registered Co-operatives for carrying of foodstuff and other materials from the Project godown to all A.W. Centres of this ICDS Project in accordance with the delivery order to be made from time to time, under the following terms and conditions. In case of co-operative society, certificate of exemption regarding earnest money/security money must be duly recommended in the name of the Co-operative society by the ARCS of the concerned district and also an under taking signed by the executive officer of the Co-operative society is to be obtained regarding participation of the said Co-operative in the particulars tenders. (Recommendation by the A.R.C.S. & under taking signed by the Executive Officer is to be enclosed with tender papers.)

TERMS AND CONDITIONS :-

01. The Sealed tenderers are to be submitted along with valid and up to date IT/ST/PT clearance certificate and a bank draft /D.C.R. having value of Rs. 10000/- (Ten thousand) only as a earnest money and duly endorsed in favour of the C.D.P.O Haldibari. The credential certificate in respect of carrying of Food Stuff of Govt. property is to be enclosed with the tender papers.
02. The successful renderers' will have to deposit Rs.20, 000/- (Rupees Twenty thousand) only as security money either in the form of D.C.R duly endorse in the name of CDPO, Haldibari.

03. The term of tenders is for one year from the date of execution of agreement to be made in accordance with Govt. rules.
04. The work order will be issued by the undersigned only after the final approval made by the District Level Tender Committee.
05. The Tenderer will be responsible for any loss/Pilferage/Damage of Food-Stuff during transit period from Project Godown to A.W.Centres.
06. Three Challans (One for A.W.Worker, One for Project and the last one for tenderer) are to be maintained by the Tenderer.
07. The rate to be quoted should be both in figure and in words.
08. The P.L.T.C. reserve the right to accept/reject any/all tenders without assigning any reason thereof.
09. Excessive lowest or highest rate (abnormal rate according to present market price) will not be accepted. Tender Forms will be issued from up to 25th Oct-16 during office hrs. on receipt of application for tender forms in plain paper from the willing tenderers. No tender Forms will be distributed after 25th Oct-2016.
10. The Tenders are to be submitted by hand in the specified tender box in the office of the undersigned. The last date of submission of tender is 25th day of Oct-2016. No tenders will be received after the stipulated date and time as mentioned above.
11. Tenders will be opened on 26th day of Oct-2016, at 1 PM. in the office of the S.D.O., Mekhliganj. Willing tenderers may remain present at the time of opening of tender.
12. Successful tenderer is liable to obey any direction, order given by the undersigned from time to time.
