Sealed re-tender are invited by the undersigned for supply dietary and miscellaneous articles to Mathabhanga Subsidiary Correctional Home for the period from 01/10/2016 to 31/03/2017 as per schedule available in the office of the undersigned, terms and condition are as mentioned below :-

1. The re-tender should reach the undersigned on or before 01.00 pm of 18/10/2016 and the same will be opened on the same day at 04.00 pm.
2. The final acceptance of the tender is subject to the approval of the DG & IG of Correctional Services, West Bengal.
3. No tender will be accepted unless it is accompanied by a sum of Rs-10,000/- Rupees-(Ten thousand) only as Earnest Money in the form of T.R. Challan / N.S.C/ K.V.P Notes to be deposited and duly endorsed in favour of the Superintendent, Mathabhanga Subsidiary Correctional Home. Bank Draft/D.C.R will not be accepted.
4. The re-tender should be accompanied with valid Trade License, I.T, S.T, P.Tax or VAT Clearance certificate, as the case may be. Experience Certificate relating to similar supply to any Government concern not less than 07 (seven) years should also be furnished along with re-tender.
5. Illegible writing or conditional rate will not be accepted. The rates should be quoted in inclusive of all taxes if any.
6. Articles need to be supplied at the gate of Correctional Home at the cost of the suppliers and in his own bags. The bags will be returned after supply.
7. All articles should be fresh and good quality.
8. Samples of all non-perishable articles must invariably be submitted along with the tender in glass containers or transparent poly packs in sealed cover, so then they can be seen from outside.
9. Supply orders are to be collected from the Correctional Home Office every day evening and supply is to be made at stipulated time fixed by the undersigned.
10. On receipt of final decision from the DG & Inspector General of Correctional Services, West Bengal, the successful Tenderers will be required to sign regular contract deed and deposit security money to obtained supply orders, failing which Earnest Money deposited with the tender will be forfeited.
11. The undersigned does not bind himself to accept the lowest rated of any re-tender, or to give any reason thereof. He also reserves the right of reducing by any amount or increasing up-to 25% of quantity tendered for in each case.
12. In case of milk or other articles the purity of which is subject to chemical test is found to be adulterated and not up to the standard, the supplier shall to bear the charges of this chemical test. The payment in respect of supplies found to be adulterated or inferior to the standard quality may be totally withheld or made at reduced rate.
13. Tenderers may remain present at the time of opening of the tender and the completion of comparative statement if they desired and they may could their initials all the tenders of their competitions as the re-tenders are opened and read out.
14. Schedule of articles will be supplied from this Office at any working days from 11.00 a.m to 12.00 noon and any other information if required may be obtained from the office of the undersigned on application.


