Sealed Tender are invited from the bonafide carrying contractors for carriages Free Text Books (FTB) for the academic year 2017 from district level godowns to circle level godown. Please examine each & every terms & condition laid down below before submitting bid.

### Terms & Conditions

1. Intending carrying contractors who are able to engage trucks having capacity of at least 9 (Nine) Tonnage and 4 (Four) Tonnage along with labour provision in sufficient number may submit the bid.
2. Tender to be submitted in the prescribed proforma under two bid system i.e, Technical Bid & Financial Bid. Both the Bid must be submitted in separate envelop.
3. Technical Bid should contain the following attested / original documents :
  - i) Application form to be filled up as prescribed in Annexure- I.
  - ii) Earnest money: Rs. 10000/- (Rupees Ten thousand) only in the form of DCR / Banker Cheque / DD in favour of the District Project Officer, Sarva Shiksha Mission, Cooch Behar.
  - iii) Credential of Rs.2,50,000/-(Two lakh Fifty thousand) in similar type of work to be submitted.
  - iv) Blue book of the truck owned in case of truck owners and upto date valid trade license in case of carrying contractors.
  - v) PAN Card.
  - vi) Valid income tax clearance certificate of last two years.
  - vii) Valid professional tax clearance certificate.
  - viii) An undertaking also be submitted in prescribed format along with other tender documents as per Annexure-III.
4. Financial Bid should contain the following documents :
  - i) The intending carrying contractors will have to submit rate per trip for 9 & 4 Ton and average rate separately in the tender paper.
  - ii) Rate should be quoted including of all taxes loading, unloading and binding charges, fuel charges etc. in the rate schedule as per Annexure-II.
  - iii) Rate should be quoted in the figure and words clearly.
5. Mode of Selection : The Comparative Statement will be generated on the basis of average rate offered by the bidder  $[(\text{Rate for 4 Tons} + \text{9 Tons}) \div 2]$ .
6. FTB for different circle may be loaded in the same vehicle to avoid piecemeal distribution. If any intentional / unnecessary shifting found in distribution process the bill of the same is to be curtailed.
7. No advance payment will be allowed.
8. Price variance will not be entertained.
9. Tender form will be issued from this office from 22.08.2016 to 30.08.2016 up to 12.00 noon.
10. Tender will be received from 22.08.2016 to 30.08.2016 up to 2.00 p.m.
11. Technical Bid will be opened and scrutinized on 30.08.2016 at 4.00 p.m. in the chamber of the District Project Officer, Sarva Shiksha Mission, Cooch Behar.

12. Tender forms will be received through register post; courier service. It may also be dropped in the tender box lying at DPO office.
13. Financial Bid will be opened on 31.08.2016 at 2.00 p.m. in the Chamber of the District Project Officer, Sarva Shiksha Mission, Cooch Behar.
14. Successful tenderer will have to shift the FTB books from the District Godown located at Ghughumari and other locations to Circle Godowns as per instruction of the authority failing which penalty as deemed to be fit by the authority will be imposed. Any deviation from the programme will cause penalty including forfeiture of earnest money and anything else.
15. The work of transportation of FTB will have to be completed by November 2016 without fail.
16. Log book to be maintained by the transporter & furnished along with bill(s).
17. TDS will be charged over final bill payment as per IT norms.
18. Unsealed tender shall be summarily rejected.
19. The undersigned reserves the right to accept or reject any or all of the tender papers without assigning any reason. The undersigned also reserve the right to forfeit the earnest money in case of any type of deviation from the specification in case of failure the tender or will not be allowed to participate in any tender in future under this department.
