EMD of the unsuccessful bidders shall be returned as promptly as possible upon award of contract.
- 9. **Security Deposit:** It shall be calculated as 8% on estimated work value. The EMD of the successful bidder shall be converted to Security Deposit and the rest amount shall be deposited by 3 days calculated from the date of opening of the tender in favour of the DPO, SSM, Cooch Behar in the shape of Demand Draft / Banker's Cheque. It shall be refunded within three months of the supply of the products and if found those items work at satisfactorily.
- 10. **Credential:** For submission of tender, the bidder shall submit self attested photocopies of payment Certificate, Completion Certificate & Work Order in support of successful completion of similar type of work of value *not less than* 50% as total value of the work for the last three years (FY 2015-16 to 2017-18) in any Government Department/ Government Undertaking/ Semi-Government Organisation / Schools /Colleges, failing which the tender shall be rejected.

- 18. The Partnership firm shall furnish the registered partnership Deed, the power of attorney for the firm for signing the tender by a partner and the company shall furnish the Article of Association and Memorandum.
- 19. Joint venture shall not be allowed.
