

Madam,

We are thinking for sometime part for organising a workshop cum awareness programme on Heritage in Coochbehar but due to ensuing pandemic situation for more than a year, this could not be held. In the meantime, we have received a proposal endorsed by Secretary, I&CA Department from the REACH Foundation which consists of Ex-ASI experts, for organizing a daylong workshop on heritage conservation in Coochbehar. The proposal appears to be beneficial for the stakeholders of heritage. Copy of the proposal is enclosed herewith for perusal

I would request you to take up the matter with District Magistrate Coochbehar for organising the programme at a suitable date. REACH Foundation has proposed 26th September, 2021 for the workshop. The District authority may consider the same or suggest any other dates.

In this context it is mentioned that the West Bengal Heritage Commission shall bear the to & fro travelling expenses for the movement of experts to Coochbehar and back to Kolkata. Accommodation, local transport food etc to be provided by the District Authority. Cost of training equipments and materials, if required would also be provided by West Bengal Heritage Commission.

Similarly, the matter may be taken up with District Magistrate, Nadia for organising such a workshop at Nabadwip.
